- **6. Communication + Time Integrity**. All communication will be done via Zoom (www.zoom.us) Audio or another online program. Even if we're next door neighbours, we'll be chatting online.
- 7. Time integrity is a real thing: Please be in time for the benefit of all who are joining.
- 8. Cancellations + Refunds.

All coaching sessions packages and online classes are final sale. There will be no refunds under any circumstances. However, this is subject to my discretion and if a refund is to be provided there is a processing fee involved

- **9. Currency**. All prices are in Canadian Dollars and all payments must be made in CAD through Paypal, Square, or e-transfer.
